#### **2) Age:**

Not less than eighteen years and upper age limit is 30 years as on 31.12.2020. The upper age limit is relaxable by 5 years for SC/ST candidate, 3 years for OBC candidates and 10 years for SC/ST Persons with Disability.

Reservation for SC/ST/OBC as per Govt. Guidelines.

#### **3) Selection:**

Candidates shall be shortlisted based on percentage of marks achieved in Academics.

Candidates will be offered the apprenticeship in order of merit.

**4) Compensation / Stipend:** Apprentices shall be paid stipend as per provisions of the Apprentice Act, 1961 and in reference to notification of the Ministry of Employment and Labour, Directorate General of Employment and Training, Govt. of India issued from time to time.

**5) Period of Apprenticeship Training:** 12 months training commencing from execution of the Contract of Apprenticeship.

**6) Location of Apprenticeship Training :** Apprentice Trainee will be placed as per Project in India.


**7) Other terms and Conditions:**

- Candidates who have passed out in the year 2019 & 2020 are eligible to apply in the aforesaid post. However, engineering graduate having job experience for a period of one year or more after acquiring required qualifications shall be eligible for being engaged as an Apprentice under the Act.
- Candidates who have secured 70% and above marks in their Final Examination (BE/B. Tech) in 2019-2020 are eligible & they must have full time regular degree.

- No travel expenses will be paid at the time of joining the training.

- Only Indian Nationals are eligible to apply.

Eligible candidates will be required to register themselves with the NATS web portal ([www.mhrdnats.gov.in](http://www.mhrdnats.gov.in)) & must be verified by the Regional Board

1. The application is liable to be rejected if the uploaded photograph / signature are not clear and recognizable. Candidates are advised to upload their most recent photograph and retain sufficient numbers of the same photograph to be used at later stages of the selection process if called for.
2. Category (General/SC/ST/OBC (NCL) as submitted at the time of application cannot be changed thereafter and no benefit of other category reservation will subsequently be made admissible at any stage of the selection process. Category as mentioned at the time of submission of application shall remain unaltered during the entire training period.
3. Candidates must write their name as it appears in the educational certificate of Secondary or equivalent examination. In case of change of name at a later stage necessary legally accepted documentary proof is to be submitted at the time of interview.
4. Candidates shortlisted would be required to furnish documents regarding proof of Date of Birth, Qualification, Category, Applicationslip etc. at the time of joining, as per intimation to be given to the shortlisted candidates.
5. All qualification certificates should be issued by a recognized Board / Institute / University only. Wherever CGPA or letter grade in a qualifying degree is awarded, equivalent percentage of marks should be indicated in the application form as per norms adopted by the University / Institute.
