The postal delay will not be considered. Applications received through e-mail will not be considered.
- 3. If the numbers of candidates applied are more in number, the written test will be taken for screening the candidates and after screening selected candidate will be interviewed by the selection committee.
- 4. The eligible candidates only will be interviewed by Selection Committee. The candidates have to attend interview on his/her own cost.
- 5. The mode of interview, either in personal presence (Offline) or online (Zoom or Google meet) that will be communicated with the call letter considering the Covid-19 situation.
- 6. The candidate has to produce all original documents at the time of interview failing which his candidature will be rejected.
- 7. The selected candidates will be required to give an undertaking that he/she will not leave the assignment halfway and shall complete the work in prescribed time limit. In this regards, the candidate selected for the post will have to execute bond on stamp paper of Rs. 100/- as per university order.
